Here is how it works:

- Hire the talent you really want for your print-only campaign
- Complete just a one-page document to become signatory for this one production all that's needed is your company name, address and a signature
- Any company involved with the production can sign production company, photographer, payroll company, ad agency or advertiser
- Payment under the contract is due only to the professional performers
- The rate is a one-time payment of no less than \$686 plus 17.25% to SAG-AFTRA Health and AFTRA Retirement Plans.
- The footage may be used for three years on the internet, point of purchase, internal corporate use, etc.
- If the footage ends up in a commercial, the Commercials Contract will apply to all talent in the spot
