

SAG-AFTRA 2023 SPECIAL AGREEMENT FOR INDEPENDENT PRODUCERS OF DRAMATIC NEW MEDIA PROGRAMS RATE SHEET

The thresholds outlined below are applicable to the total production budget for the program or, in the case of a series, the per-episode budget.

CATEGORY A:

FOR EPISODIC PROJECTS* WITH BUDGETS OF AT LEAST \$50,000 BUT LESS THAN \$300,000

All Performers except Stunt Coordinators
Background Actors & Stand-Ins

20% of the TV Agreement day rate 75% of the applicable TV Agreement rate

Stunt Coordinators

Rates for Daily, Weekly, and "Flat Deal" Stunt Coordinators track the applicable rate in Schedule K-I, K-II, or K-III of the Basic Agreement that is current at the time of photography.

CATEGORY B: FOR EPISODIC PROJECTS* WITH BUDGETS OF AT LEAST \$300,000 BUT LESS THAN \$700,000

All Performers except Stunt Coordinators
Background Actors & Stand-Ins

35% of applicable TV Agreement (daily or weekly) 75% of the applicable TV Agreement rate

Stunt Coordinators

Rates for Daily, Weekly, and "Flat Deal" Stunt Coordinators track the applicable rate in Schedule K-I, K-II, or K-III of the Basic Agreement that is current at the time of photography.

CATEGORY C: FOR PROJECTS WITH BUDGETS OF AT LEAST \$700,000 BUT LESS THAN \$1,000,000

All Performers except Stunt Coordinators
Background Actors & Stand-Ins

65% of applicable TV Agreement (daily or weekly) Full Applicable TV Agreement rate

Stunt Coordinators

Rates for Daily, Weekly, and "Flat Deal" Stunt Coordinators track the applicable rate in Schedule K-I, K-II, or K-III of the Basic Agreement that is current at the time of photography.

CATEGORY D: FOR PROJECTS WITH BUDGETS \$1,000,000 AND ABOVE**

Full rates as set forth in the 2023 SAG-AFTRA Television Agreement. Please note that the full terms and conditions of the SAG-AFTRA Television Agreement may apply to this budget level as well.
