STEPS TO JOIN

INTIMACY COORDINATORS are eligible to join SAG-AFTRA if they can provide proof of employment as an intimacy coordinator on an Alliance of Motion Picture and Television Producers (AMPTP) production.

What Do You Need To Qualify?

Proof of employment. SAG-AFTRA membership is available to those who work in the position of an intimacy coordinator covered by a SAG-AFTRA collective bargaining agreement with the AMPTP, provided they have completed one day of work as an intimacy coordinator.

What Are The Costs To Join?

Any current intimacy coordinator who is working on an AMPTP production who fulfills the application requirements within one year following a duly ratified collective bargaining agreement for the bargaining unit will receive a waiver of the applicable initiation fee. Regular base dues will be charged in the amount of \$118.30 semi-annually. One year following ratification of the first agreement, work dues will then be charged based on the previous year's SAG-AFTRA-covered earnings.

Eligibility Verification

Each application is vetted for legitimacy. That means your proof of employment will be fully investigated by SAG-AFTRA for validity. Your application for membership will be denied if you have falsified your credentials or if your qualifying employment is not bona fide.

While it is your responsibility to ascertain the validity of your qualifying employment, the union will be the sole arbiter in determining whether the employer was legitimate, and whether the qualifying employment which you performed was actual production work or work created solely to enable you to gain union membership. Please be aware that false representation or deception on your part will jeopardize your chances to join SAG-AFTRA.

Moreover, if, after your application has been granted, the union discovers such misconduct on your part, you may find yourself subject to disciplinary proceedings, which could result in your being fined, suspended and/or expelled from SAG-AFTRA.

Submitting Proof of SAG-AFTRA Eligibility

PLEASE SUBMIT ONE OF THE FOLLOWING DOCUMENTS:

PAYCHECK STUBS

The paycheck stubs must indicate date of employment, intimacy coordinator's name and Social Security number, production title, signatory company and wages paid.

INTIMACY COORDINATOR CONTRACT

The original contract with the intimacy coordinator's name and Social Security number, date of employment, production title, signatory company and wages paid.

PAYROLL PRINTOUT

The payroll printout will include the intimacy coordinator's name and Social Security number, date of employment, production title, signatory company and wages paid.

IN ADDITION TO ENCLOSING PROPER ELIGIBILITY DOCUMENTATION, YOU MUST INCLUDE THE FOLLOWING INFORMATION:

- Professional name
- Current primary address
- Current telephone numbers
- Date of birth
- Place of birth (city and state)
- Social Security number
