I have been advised that the above-named Project is signatory to the SAG-AFTRA Micro-Budget Project Agreement ("Agreement").

I understand and acknowledge the following:

- The Project is covered by a SAG-AFTRA Agreement that does not set forth any minimum terms and conditions and I am free to negotiate all terms and conditions of my employment with the Producer.
- No contributions will be made on my behalf to the SAG-AFTRA Health Plan, the SAG Pension Plan, the AFTRA Health and Retirement Plan, or any successor pension or health plan. My work on the Project will not in any way count toward benefits in any of the plans.
- SAG-AFTRA has not taken steps to confirm whether Producer has insurance, including workers compensation insurance, or whether Producer is complying with any applicable protocols relating to COVID-19. I understand that I may seek these assurances directly from Producer.
- SAG-AFTRA has provided The Safe Way Forward and other relevant COVID-19 Safety Protocols to the Producer, but has not taken steps to confirm whether Producer has complied with these protocols. I understand that I may seek these assurances directly from Producer.
- If I am not yet a SAG-AFTRA member, my work in the Project will not in any way qualify me for or count toward SAG-AFTRA membership eligibility.
- In SAG-AFTRA's sole discretion, it may initiate a grievance if the Producer has made misrepresentations in connection with the Agreement or if SAG-AFTRA, in its sole discretion, has determined the Project is ineligible for the Agreement. SAG-AFTRA has no obligation to represent me in any matters, including any grievances, relating to the Project or the Agreement unless or until the Project is reclassified as set forth therein.
- I am granting Producer the right to use my name, image, likeness, voice, and performance only in the exhibition markets described in the Agreement. If Producer exhibits the Project beyond these markets, I may pursue appropriate legal recourse in court.
