C. Compensation: Producer must make contributions to the Screen Actors Guild Pension and SAG-AFTRA Health Plans at the current rates specified in the Short Project Agreement for all compensation paid to Background Actor. Background Actor compensation must be paid in accordance with the minimums set forth within the SAG-AFTRA Short Project Agreement executed to cover the Project noted above. Background Actor compensation shall be the following (Please attach a rider if additional space is needed to describe the deal terms.):

Overtime shall be paid for work in excess of eight (8) consecutive hours, exclusive of meals, at the rate of time-and-one-half per hour for the 9th through 12th working hours, or parts thereof, payable in tenth of hour (six (6) minute) units of work time. If a Background Actor is required to work beyond twelve (12) hours in any day, such Background Actor will be due overtime at double the greater of the Basic Agreement straight time rate for Background Actors or the Background Actor's negotiated rate, for any time worked, payable in tenth of hour (six (6) minute) units. Overtime due for work beyond twelve (12) hours in a day may not be deferred.

Payment is deferred. Payment will be due if the Project subsequently exhibits on a consumer pay New Media platform, including download to rent or own platforms, and/or any subsequent exhibition in Traditional Media, as defined in the SAG-AFTRA Short Project Agreement.

3. AGREEMENTS: All provisions of the collective bargaining agreement between SAG-AFTRA and Producer relating to short projects shall be deemed incorporated into this Agreement. "Basic Agreement" means the current Producer-Screen Actors Guild Codified Basic and Television Agreements.

4. ARBITRATION: Disputes regarding the interpretation, application or alleged violation of this Agreement will be submitted to binding arbitration in California under the procedure in the applicable SAG-AFTRA Short Project Agreement.
