Secretary - Shane Carson



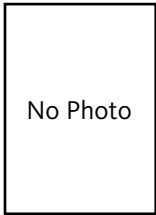

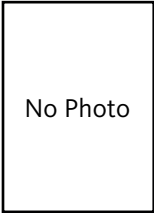
